The renewable energy surcharge and the price of system services and market operator services is determined by Energy Regulatory Office decision No. 6/2017; the electricity tax rate is determined by Act No. 261/2007 Sb. Prices of related services are determined by the price decision of the Energy Regulatory Office and cannot be influenced by PRE in any way.
