How can you calculate your total annual payment for electricity?

HT = annual consumption in HT × (row **25** = **1 + 4 + 5 + 23**)

+ **LT** = annual consumption in LT × (row **26** = **2 + 4 + 6 + 23**)

+ **monthly payments** = 12 × (row **3** + one of the rows **7–20** based on circuit breaker amperage + row **24**)

+ **the lower result of possible renewable surcharge calculations:**

based on consumption = electricity consumed × row **22**, or based on circuit breaker

amperage = 12 × main circuit breaker amperage × number of phases × row **21**
