A single-tariff product suitable for customers using electricity for usual purposes.

A double-tariff suitable for customers with storage heaters. The tariff is available only for customers who have an electricity storage heater for heating or water heating. The customer has to ensure that the storage heater is technically disabled at the times of the high tariff.
