• ³⁾ The maximum amount of the renewable energy surcharge per consumption point in an invoicing period is calculated as follows: 495 CZK/MWh multiplied by the total consumption of electricity from the distribution network. The renewable energy surcharge and the price of system services and market operator services is determined by Energy Regulatory Office decision No. 6/2017; the electricity tax rate is determined by Act No. 261/2007 Sb. Prices of related services are determined by the price decision of the Energy Regulatory Office and cannot be influenced by PRE in any way.
