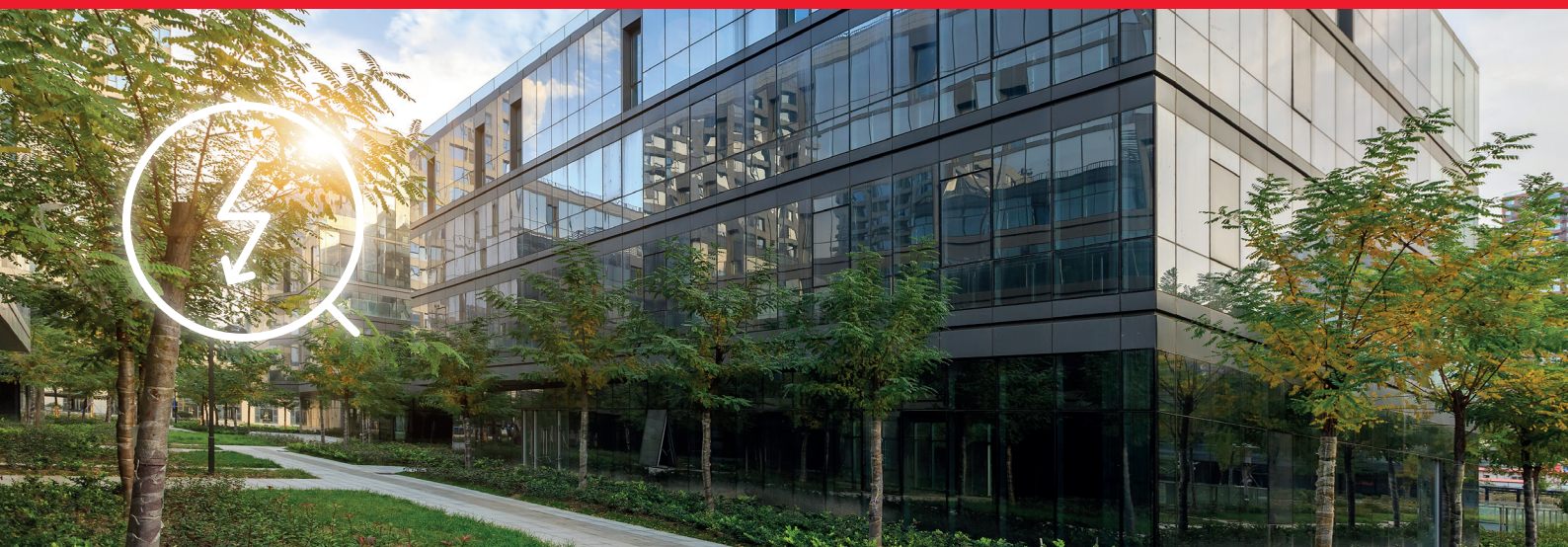

Notes: ¹⁾ Products may be combined with the distribution tariffs in the respective columns only. ²⁾ In accordance with Energy Regulatory Office price decision No. 6/2019 (applicable for the electricity distribution network operated by E.ON Distribuce, a.s.). The renewable energy surcharge and the price of system services and market operator services is determined by Energy Regulatory Office decision No. 5/2019; the electricity tax rate is determined by Act No. 261/2007 Sb. Prices of related services are determined by the price decision of the Energy Regulatory Office and cannot be influenced by PRE in any way.

How can you calculate your total annual payment for electricity?
HT = annual consumption in HT × (row **25** = **1** + **4** + **5** + **23**)
+ LT = annual consumption in LT × (row **26** = **2** + **4** + **6** + **23**)
+ **monthly payments** = 12 × (row **3** + one of the rows **7–20** based on circuit breaker amperage + row **24**)
+ **the lower result of possible renewable surcharge calculations**:
based on consumption = electricity consumed × row **22**, or based on circuit breaker amperage = 12 × main circuit breaker amperage × number of phases × row **21**
