How can you calculate your total annual payment for electricity?

HT = annual consumption in HT x (row 25 = 1 + 4 + 5 + 23)

+ LT = annual consumption in LT x (row 26 = 2 + 4 + 6 + 23)

+ monthly payments = 12 x (row 3 + one of the rows 7–20 based on circuit breaker amperage + row 24)

+ the lower result of possible renewable surcharge calculations:

based on consumption = electricity consumed x row 22, or based on circuit breaker

amperage = 12 x main circuit breaker amperage x number of phases x row 21
