Prices inclusive of VAT are only approximate, as they have been calculated on the basis of prices exclusive of VAT and rounded up/down. The prices exclude natural gas tax (environmental tax).

m³ = cubic metre, kWh = kilowatt hour (1 kWh = 0,001 MWh). The approximate conversion 1 m³ = 10,55 kWh is applied to convert the volume of consumed natural gas from m³ to kWh.

**Notes:**\* This means the converted annual consumption determined by the distributor in accordance with relevant legislation. \*\* The fixed price for gas distribution includes a fixed fee for the market operator's activities equalling to 2,44 CZK/MWh (fixed clearing price of 1,10 CZK/MWh and a special fee of 1,34 CZK/MWh, as determined by a government regulation, for the operations of the Energy Regulatory Office pursuant to Section 17d of Act No. 458/2000 Sb., as amended).

## PRICE OF GAS SUPPLY CONSISTS OF

- price for consumed gas
- fixed monthly charge for the consumption point

This is the part of the gas price which we - as a gas supplier - can influence.

## PRICE OF RELATED SERVICES AND TAXES CONSISTS OF

- fixed price of gas distribution
- price of market operator services
- fixed monthly charge for available capacity
- gas tax (household customers do not pay this tax pursuant to Section 8, Article LXXII of Act No. 261/2007 Sb.)
- VAT (applicable VAT rate)

We cannot influence this part of the price. The price of distribution and related services is determined by the Energy Regulatory Office and tax rates by law.
